Handling

⚠ Caution

1. Strictly observe the precautions on vacuum equipment and safety when using the product. Additionally, select a cup size and material suitable to both the workpiece to be adsorbed and the atmosphere.
Take safety measures so that any accident, such as the dropping of a workpiece, does not occur during adsorption transfer. For details, refer to the **Web Catalog**.
2. Use the product within the specification range. Use exceeding the voltage may result in serious damage due to reduced product performance.
3. Exhaust air is released from the opening in the product. Therefore, do not restrict the exhaust air by blocking the opening.



4. The electric vacuum gripper monitors the pressure and controls the operation for grip and release movements. The integrity of the system should be determined after thorough verification on the actual machine.

Mounting

⚠ Caution

1. For details on the mounting method, refer to the Operation Manual.
2. Tighten to the specified tightening torque. If the tightening torque is exceeded, the body and the mounting screws may break.
3. Do not drop, strike, or apply excessive impact to this product. Doing so may result in damage to the internal parts of the body, atmospheric release valve, pressure monitor, or vacuum pump. In some cases, this damage may result in a malfunction.
4. The bolts may loosen due to the operating conditions and environment. Be sure to conduct maintenance such as tightening the bolts periodically.

1. Avoid repeatedly bending or stretching the connector cable as well as applying force to it.
2. Do not wire while energizing the product. Doing so may result in damage to the internal parts of the atmospheric release valve, pressure monitor, or vacuum pump. In some cases, this damage may result in a malfunction.
